

# FINANCIAL AID APPLICATION INSTRUCTIONS

You must submit the following to be considered for Federal, State and Pratt at Munson-Williams-Proctor Institute aid (including bank loans) for the academic year 2002-2003 (Fall 2002 - Spring 2003):

#### 1. PRATT at Munson-Williams-Proctor Institute APPLICATION FOR FINANCIAL AID.

This form is required of all students applying for Pratt at Munson-Williams-Proctor Institute financial aid. *Be sure that you complete all applicable sections.* 

# 2. FREE APPLICATION FOR STUDENT AID (FAFSA).

This form is required for consideration for ALL FEDERAL FINANCIAL AID which includes the following: Federal Pell Grant

Federal SEOG (Supplemental Educational Opportunity Grant)

Federal Work-Study

Federal Family Education Loans: Stafford (subsidized and unsubsidized) and PLUS (Parent Loans for Students)

NEW STUDENTS: The Free Application for Student Aid (FAFSA) is enclosed. You need to complete this only **once annually** and indicate all the schools to whom you want the results sent. **BE SURE TO INCLUDE PRATT at MUNSON-WILLIAMS-PROCTOR INSTITUTE'S FEDERAL TITLE IV NUMBER: 002798** 

#### 3. TAP (TUITION ASSISTANCE PROGRAM) FOR NEW YORK STATE RESIDENTS ONLY.

All *New York State residents* are expected to file a FAFSA which triggers an Express TAP Application (ETA) from New York State Higher Education. If you appear to be eligible we will automatically factor this in when calculating your financial aid.

#### DEADLINE DATE FOR ALL OF THE ABOVE FORMS: MARCH 1, 2002

Mail the Pratt at Munson-Williams-Proctor Institute Application for Financial Aid to: Financial Aid Office, Pratt at Munson-Williams-Proctor Institute, 310 Genesee Street, Utica NY 13502. Mail the FAFSA form in the self-addressed envelope in the FAFSA booklet.

# 4 INCOME TAX RETURNS FOR 2001 (Parents and Students).

A *signed copy of all pages and schedules* of the parents' and students' 2001 U.S. Income Tax Return must be submitted. If you or your parents did not submit a tax return for 2001 you must submit a signed *notarized* statement to that effect.

# 5. PERMANENT RESIDENT ALIENS.

Permanent Resident Aliens, refugees and other eligible non-citizens must provide a photocopy of their alien registration card or other documentation (first-time applicants only). If your residence status is not confirmed by the INS, you will be required to submit these documents in person for inspection by a financial aid counselor.

# 6. SOCIAL SECURITY CARD AND DRIVER'S LICENSE.

A photocopy of your Social Security Card and a photocopy of your driver's license (if you have one) must be submitted with your Pratt at Munson-Williams-Proctor Institute Application for Financial Aid (first-time applicants only).

# 7. FINANCIAL AID TRANSCRIPT (ONLY FOR SPRING 2001 ENROLLMENT).

If you are a new, transfer student, ask each institution that you previously attended for a Financial Aid Transcript, whether you received financial aid or not.

# 8. FEDERAL STAFFORD SUBSIDIZED, UNSUBSIDIZED AND PLUS LOANS.

Applications must be obtained from the Financial Aid Office, lender or guarantor. Allow 6-8 weeks for processing. A needs analysis is required for all bank loans which means you must file a FAFSA and submit the forms indicated above before we can process any bank loan.

# 9. INTERNATIONAL STUDENTS.

International students are not eligible for any financial aid except merit scholarships or departmental awards. These awards are usually not made to incoming students but are available after you have completed one or more semesters at Pratt at Munson-Williams-Proctor Institute.
