STUDENT-AT-LARGE

This application is for students who will enter Columbia College Chicago in the Spring of 2001, the Summer of 2001, the Fall of 2001, the Spring of 2002 or the Summer of 2002.

A student-at-large is an adult student (age 18 or older) who is NOT seeking a college degree. Students-at-large often enroll in classes for skill enhancement, personal growth and satisfaction or as a way to explore new disciplines before committing to a full college degree program. Students may enroll in as many or as few courses as they wish.

Important Admissions Information:

- Students-at-large register for classes after degree-seeking students.
- Students-at-large must meet relevant pre-requisites for upper-level classes.
- Students-at-large who wish to apply for admission to the degree program, including 2nd Bachelor's degree, must complete a separate undergraduate application process.
- Students-at-large may apply for admissions to the college's regular degree program at any time, but a student cannot change his or her degree-seeking status mid-semester. Students who register as students-at-large will complete that semester as a student-at-large; if a student-at-large applies for and is admitted to the regular degree program, he or she can begin studies as a degree-seeking student in the next available semester.

Important Financial Aid Information:

- Students-at-large are NOT eligible for financial aid through federal, state, or institutional programs, nor are they eligible for Veterans' benefits.
- Students-at-large may be eligible for assistance through their employers if such employers offer this benefit to their employees.
- Students-at-large must make satisfactory academic progress during the time they are enrolled as a student-at-large (NOTE: satisfactory academic progress measured during the time a student enrolls as a student-at-large can affect that student's eligibility for financial aid if he or she later chooses to attend as a regular degree-seeking student). For additional information, refer to the college catalog or contact an academic advisor.

Student-at-Large Admission Requirements

1. Students-at-large must complete the Student-at-Large Application. There is a \$25.00 non-refundable application fee (check or money order only) payable to Columbia College Chicago.
2. Students-at-large must be at least 18 years of age at the time of enrollment.
3. Students-at-large who enroll in six (6) credit hours or more must comply with Illinois Public Act #85-1315 regarding submission of medical records showing proof of specific immunizations as follows: one tetanus/diphtheria shot within the last ten years, two separate measles shots during your lifetime, one rubella shot and one mumps shot. Students who enroll in less than six credit hours and/or students born prior to January 1, 1957 are exempt from complying with Illinois Public Act #85-1315.
