

CERTIFICATION OF FINANCIAL SUPPORT

All students must show the ability to meet financial costs to travel to the United States, complete their education and return home. The Certification of Financial Support form is to be completed and returned to the Bethel College Office of Admission. Bank statements, letters of award or affidavits of support must accompany the form and show proof of the student's financial responsibility and intent to pay.

Financial assistance thorough Bethel College is very limited for international students. Therefore, each student is responsible for finding his or her own source of funds. International scholarships are available to traditional undergraduate students who meet the appropriate admission criteria. They are awarded by the International Admission Committee. Award amounts vary from \$3000-full tuition. International students receiving these scholarships are expected to live on campus and contribute to the Bethel community life. In addition, international students have the option of earning up to \$4000/year through on-campus jobs.
