## THE BASICS

 Please complete and submit Part II of the application and return it to the Office of Admissions. The remaining documents needed to complete your application file are contained in this packet. We ask that these documents be submitted to the Office of Admissions by the deadline for the Decision Plan which you have chosen. For an application file to be considered, the following materials must be submitted:

## First-year students

- Application for Admission (Part I and II) with a nonrefundable \$40 application fee.
- Attach personal statements (Admissions Essay) as instructed on page 3 of the application.
- Have your official transcript sent by your high school. If you have attended more than
  one high school, you must request an original official transcript from each school.
  You are also required to request a mid-year report/transcript.
- Either SAT I with writing score or ACT with writing score is required. Have your scores sent by the appropriate testing service or your high school. The Test of English as a Foreign Language (TOEFL) is accepted in place of the SAT or ACT for students whose native language is not English. Furman's test code is 5222 for SAT I. Furman's ACT test code is 3858.
- Have your guidance counselor complete and mail the Secondary School Report Form.
   Your counselor should provide class rank and size if available, grading scale and a list of your senior courses, indicating the highest course level available in each subject.
- Evaluative interviews are **not** used in the admissions process. Campus information sessions—recommended but not required—are led by admissions counselors for prospective students. These sessions can be arranged through the Office of Admissions with one week's notice <www.engagefurman.com/visit>.

## **Transfer students**

- Application for Admission (Part I and II) with a nonrefundable \$40 application fee.
- Have Dean's Statement for Transfer Students completed and returned.
- Have your official high school transcript, bearing a date of graduation sent by your high school guidance office.
- Have an official transcript sent from each college or university you have attended or are attending. You must be in good standing at your most recent school.
- Standardized test scores are required unless a student (1) has earned 32 or more
  transferable semester hours or (2) has reached his/her 21st birthday. Furman accepts
  either the American College Test (ACT) or Scholastic Aptitude Test (SAT) scores. The Test
  of English as a Foreign Language (TOEFL) is accepted for students whose native language
  is not English.
- Attach a statement of your educational goals and reasons for transferring.

Fall Term 2006: September 13 – December 15

**Deadline for postmarking application:** June 2, 2006 (Review of applications begins early January, and continues on a space available basis after March 15.)

Notification of decision: March 15, continuing afterwards on a rolling basis. (Notification on a rolling basis normally follows within two weeks of filing of application, beginning March 15.)

Payment due for enrolling students: May 1, 2006, or two weeks from date of notification, whichever is later.

# **DECISION PLANS**

Early Decision application is for prospective freshmen who have decided Furman is their first choice. Applications must be postmarked by November 15 (Part I and Part II). Late applicants are considered under the Regular Decision plan. Early Decision applicants receive notification in mid December. Approved applicants who wish to enroll must submit a \$400 nonrefundable deposit and signed Statement of Intent, postmarked by January 15. Students depositing at Furman must withdraw applications to all other schools. Early decision is binding at the point of deposit.

Regular Decision application is for all other students. Applications must be postmarked by January 15 (Part I and Part II), with notification of decision from Furman mailed in mid March. Late applications are considered on a space-available basis. Approved applicants who wish to enroll must respond with a \$400 non-refundable deposit and signed Statement of Intent, postmarked by May 1.

**Early Admission** application is available for those students who will enter college after three years of high school work. In addition to the requirements listed above, Early

Admission candidates must interview with a member of the admissions staff and be enthusiastically recommended by their guidance counselor or principal. Minimum requirements include rank in the top 10 percent of their class and SAT scores of at least 1300 or ACT composite score of 30. Early Admission candidates must apply under the Regular Decision plan and must submit a mid-year report from the high school

## COMPLETING YOUR APPLICATION

You will be notified by mail when your application is received, when it becomes complete, and if items are missing from your application file. Frequently, items you have requested from your high school guidance counselor and Furman's notification of items missing, cross in the mail. Our experience is that many high school counseling offices are burdened by requests received near college application deadlines. Your timely written request will be most appreciated by your guidance counselor. Please keep in mind that documents received after March 1 may not be received in time to complete your file in order for us to render a decision. Furman University reserves the right to require additional documentation upon request.

## **CONFIRMATION OF ADMISSION**

Enrolling students will be required to submit a final secondary school transcript, including date of graduation, upon the completion of their senior year. A significant decline in academic performance or personal behavior may give the Admissions Committee cause to rescind admission to Furman.

## **APPLICATION FEE WAIVERS**

The application fee of \$40 may be waived upon submission of one of two forms. Furman participates in the College Board Fee Waiver program. If you have received the benefit of a College Board Fee Waiver for testing, you may be eligible to receive a waiver for your application fees. Furman accepts the National Association of College Admissions Counseling request for application fee waiver form as well. Both forms should be available from your guidance office. Please contact your guidance counselor with additional questions

## **HOME-SCHOOLED APPLICANTS**

Furman requires an outline of topics or curriculum covered in the secondary school experience.
