****Expenses are estimated, and subject to change each year without notice.** Students and their sponsors should expect an 8 to 10 percent increase in both tuition and cost of living for each year in attendance. Complete funding, for the first year of study must be demonstrated. *Medical insurance is required of all international students.* You must participate in the University's student health insurance group plan, or provide evidence of comparable insurance upon arrival.

Additional financial support should be demonstrated for accompanying dependents. Please add \$3,000 for a spouse and \$2,500 for each child. Include the names, with family name in capital letters, dates of birth, country of citizenship and relationship to the student on a separate sheet of paper.

Students should not anticipate working in the U.S. to offset the cost of education. Students holding F-1 visas (student non-immigrant status) are not eligible to work off campus. On campus employment is very limited and competitive and usually pays minimum wage. Only part-time (17 hours per week) employment may be authorized on campus.

Students must secure reliable and full funding for the duration of their studies. Neither federal and state financial aid nor scholarships are available to international students. Extremely limited, highly competitive partial tuition merit grants are available after 30 credit hours of university study are completed in the U.S. There is no application; students are considered when eligible.

Full payment is due at the beginning of each term. Be sure to know your government's regulations regarding foreign exchange and transfer of funds to the U.S. Make arrangements **before** leaving your country to ensure complete funding for the beginning of each term and at regular intervals throughout the year. You may make a copy of this form as documentation for the estimated cost of your studies. *Your registration will be cancelled if complete payment is not received at registration.*

Together with this form, you must also complete the *Affidavit of Support* on the reverse of this page, have it notarized, and submit a letter from the sponsor's bank showing that sufficient funds are available to support your studies. *Sponsors may not be individuals currently holding non-immigrant student status in the U.S. (Those with F-1 or J-1 status may not sponsor your studies.) List the names and addresses of the person and/or agencies providing financial support for the duration of your studies and sign the form.*

I have read the above information regarding the funding of studies at Roosevelt University, and I understand that I must secure complete funding for all expenses while attending the University.
